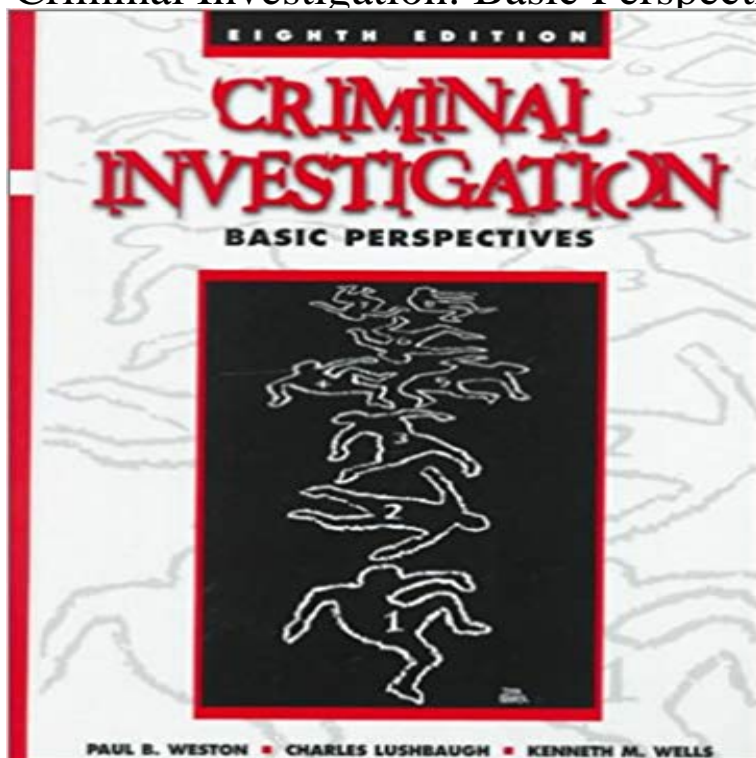


## Criminal Investigation: Basic Perspectives (8th Edition)
