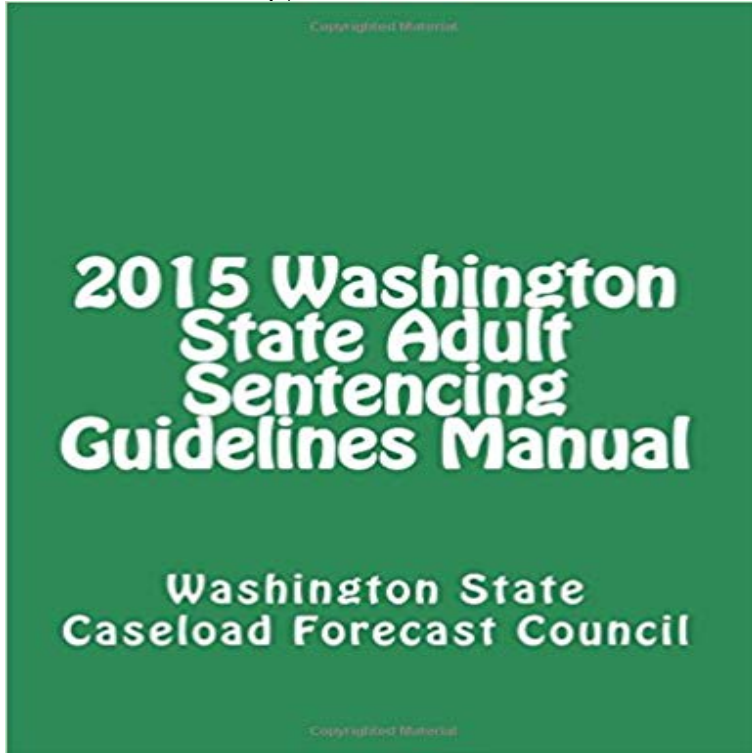


2015 Washington State Adult Sentencing Guidelines Manual
