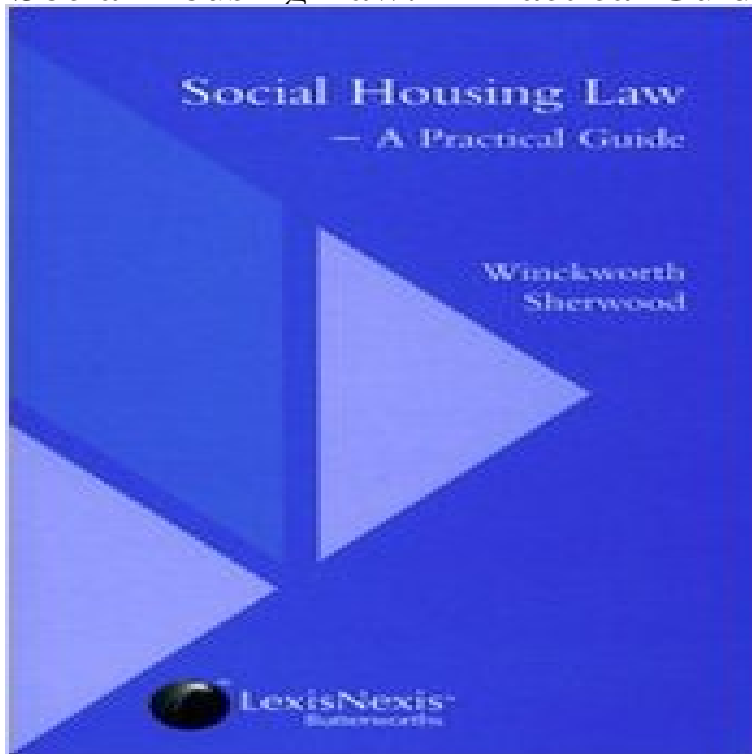


## Social Housing Law: A Practical Guide
