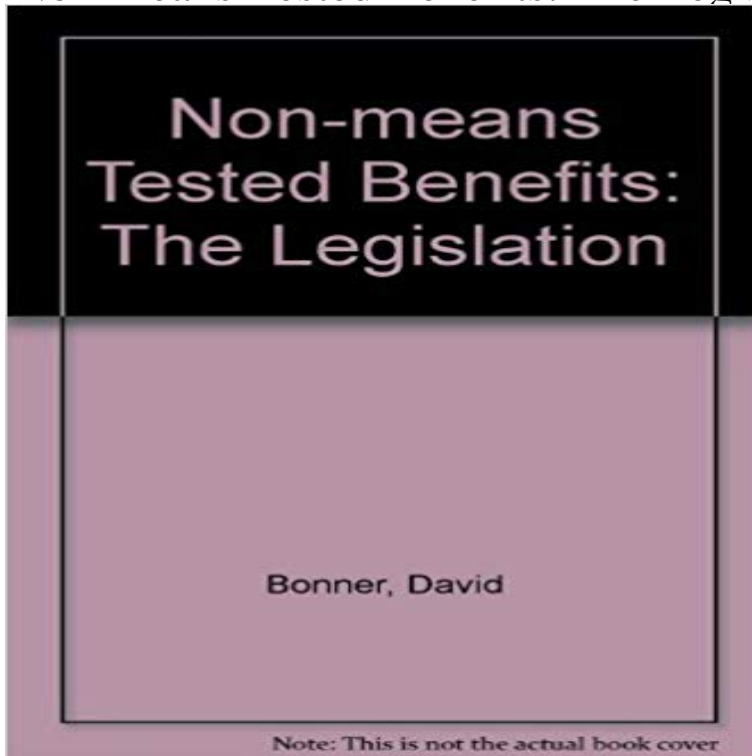


## Non-means Tested Benefits: The Legislation
