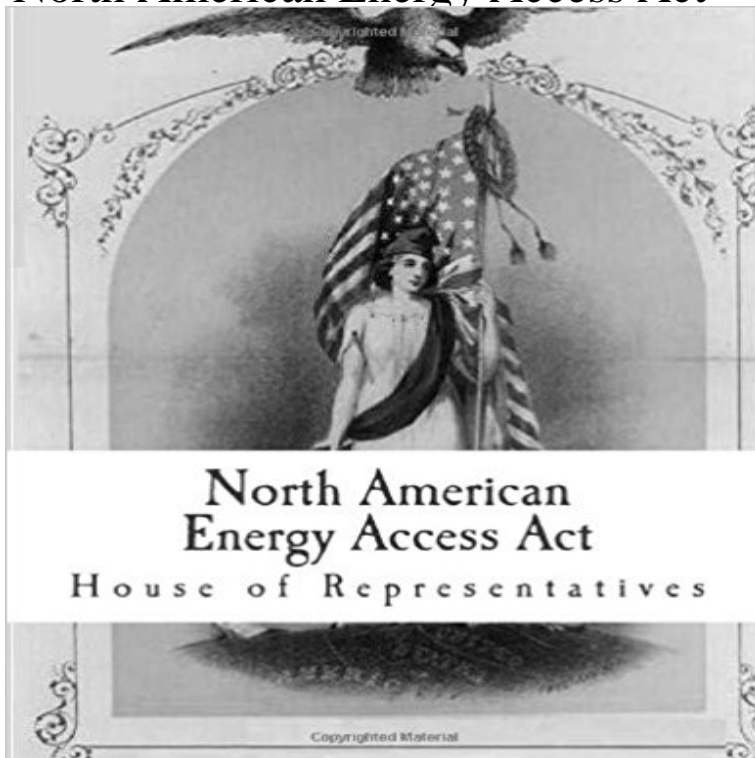


North American Energy Access Act



Strike all after the enacting clause and insert the following: SECTION 1. SHORT TITLE. This Act may be cited as the North American Energy Access Act. SEC. 2. RESTRICTION. (a) IN GENERAL.No person may construct, operate, or maintain the oil pipeline and related facilities described in subsection (b) except in accordance with a permit issued under this Act. (b) PIPELINE.The pipeline and related facilities referred to in subsection (a) are those described in the Final Environmental Impact Statement for the Keystone XL Pipeline Project issued by the Department of State on August 26, 2011, including any modified version of that pipeline and related facilities.
