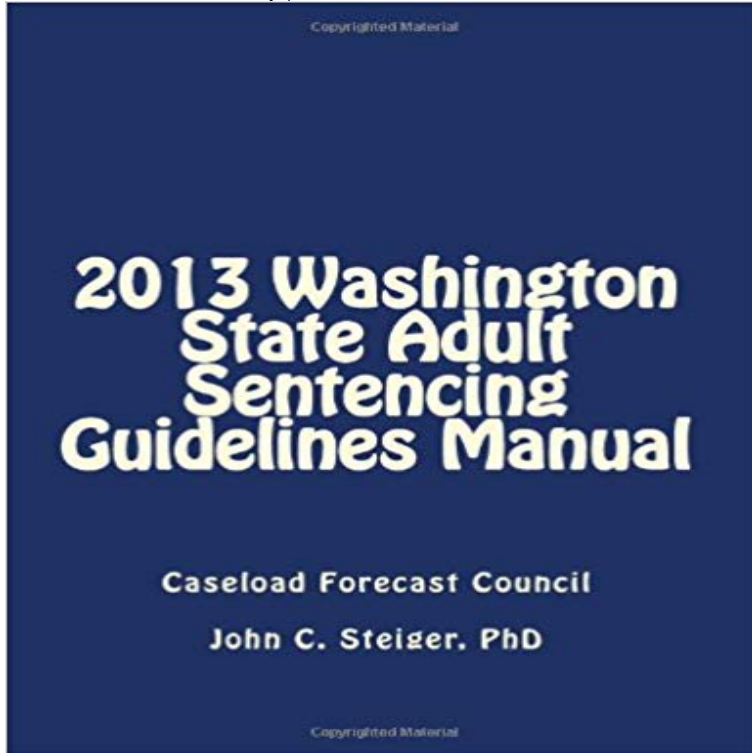


# 2013 Washington State Adult Sentencing Guidelines Manual
