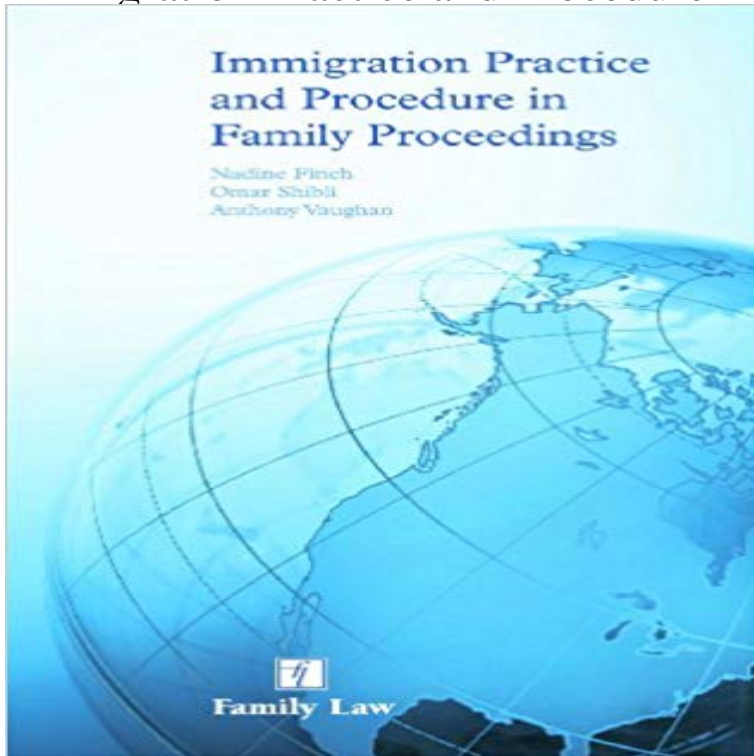


# Immigration Practice and Procedure in Family Proceedings
