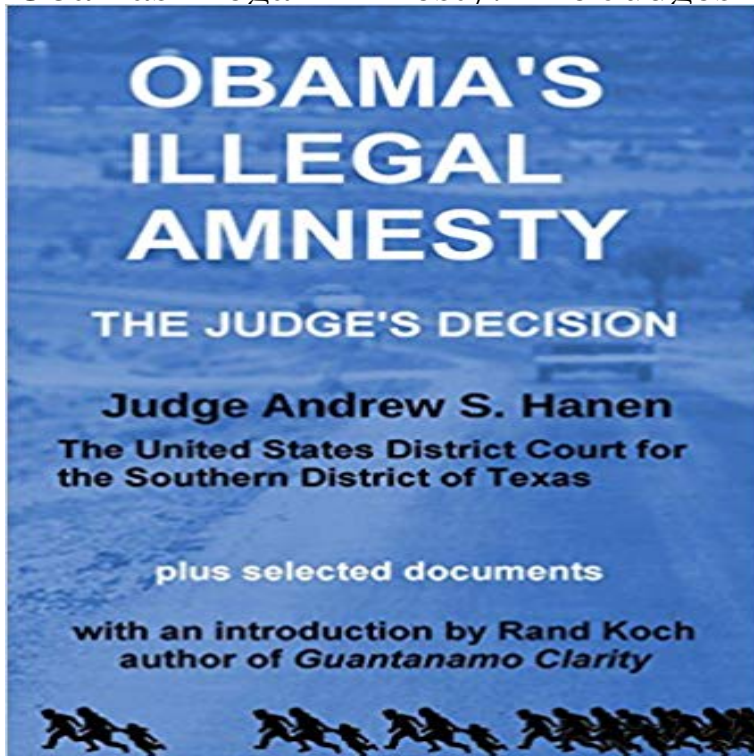


## Obamas Illegal Amnesty: The Judges Decision
