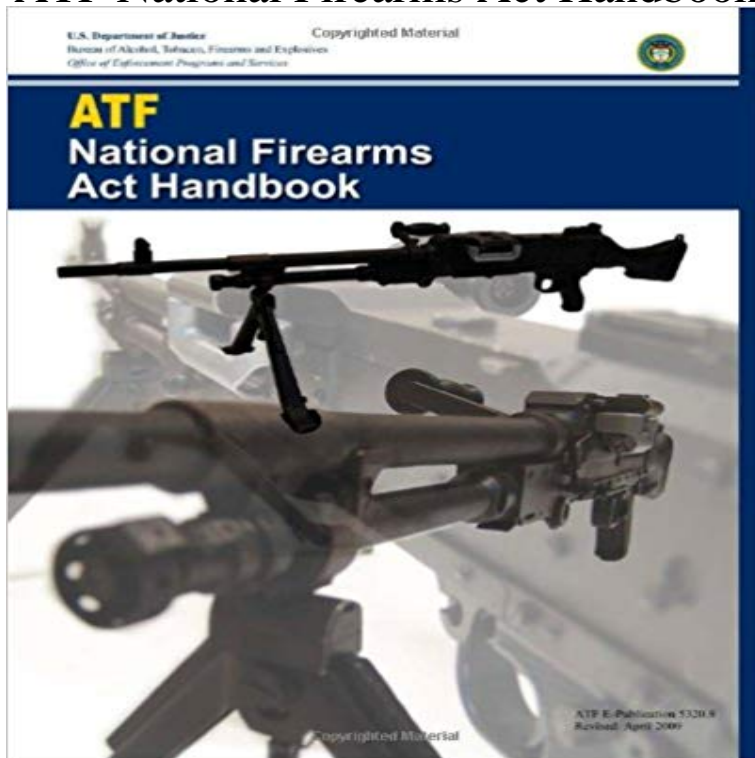


# ATF National Firearms Act Handbook
