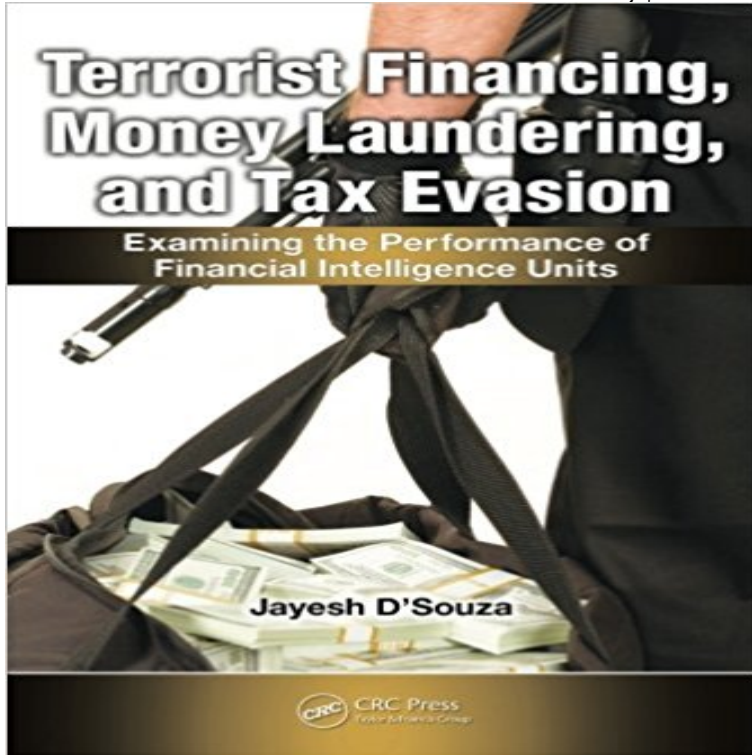


Terrorist Financing, Money Laundering, and Tax Evasion: Examining the Performance of Financial Intelligence Units

It concludes with a survey of experts opinions on the efficacy of current programs and recommendations for improving government performance in countering terrorist financing and related money laundering and tax evasion. Knowing what to target and how to measure results are essential for performance enhancement in preventing and interdicting financial criminal activity. Establishing the need for accurate assessment of the success and failure of FIUs, the book demonstrates how monitoring and measuring progress is a

crucial part of financial interdiction efforts in the fight against terrorism.
