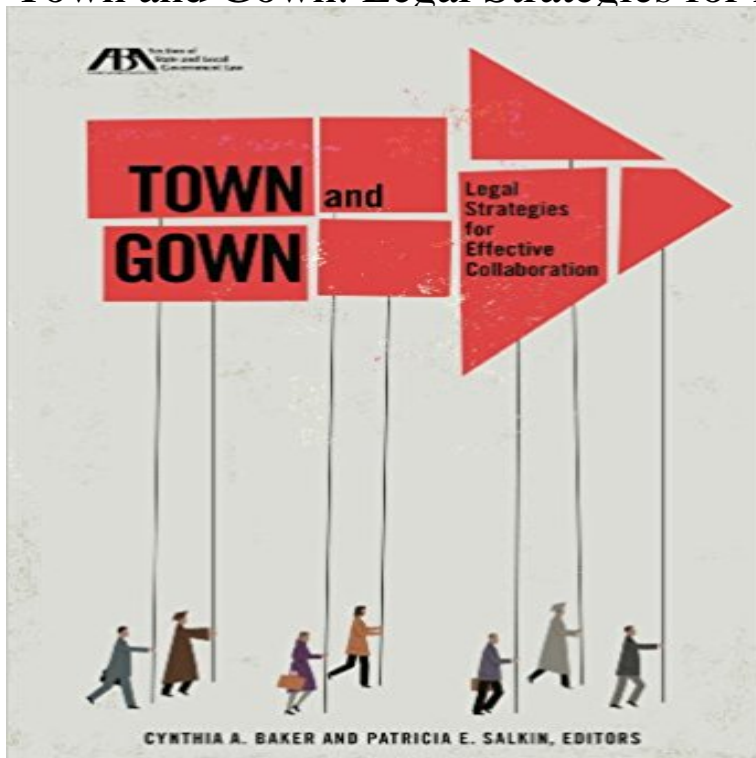


Town and Gown: Legal Strategies for Effective Collaboration
