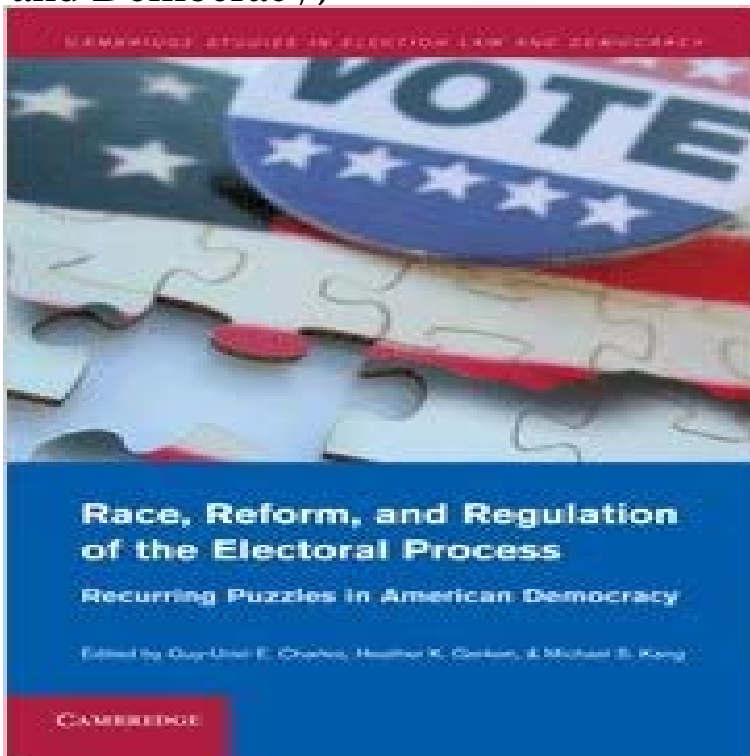


Race, Reform, and Regulation of the Electoral Process: Recurring Puzzles in American Democracy (Cambridge Studies in Election Law and Democracy)
