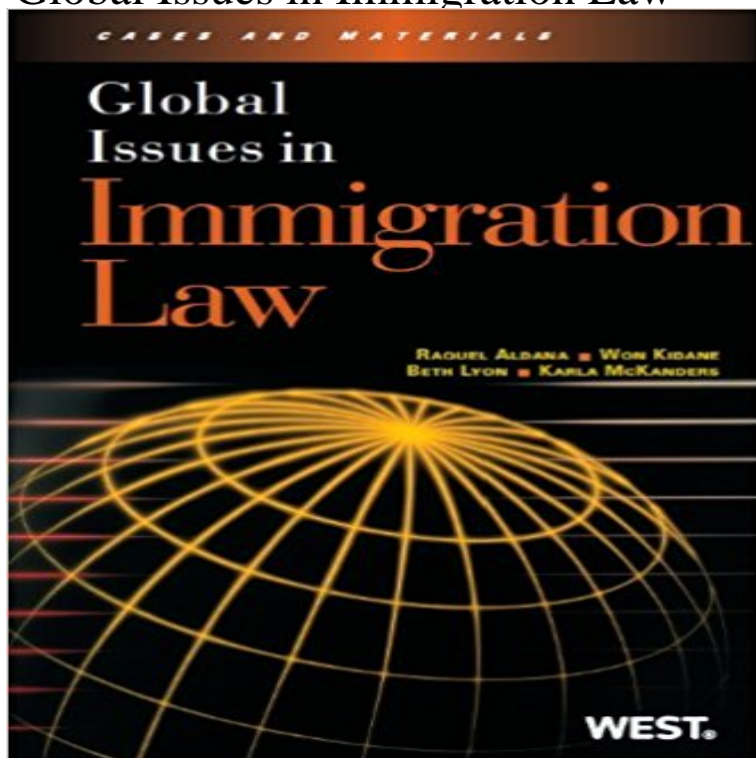


Global Issues in Immigration Law
