2011 Year-End Report on the Federal Judiciary

In 1920, American baseball fans were jolted by allegations that Chicago White Sox players had participated in a scheme to fix the outcome of the 1919 World Series. The team owners responded to the infamous "Black Sox Scandal" by selecting a federal district judge, Kenneth Mountain Landis, to serve as Commissioner of Baseball and restore confidence in the sport. The public welcomed the selection of a prominent federal judge to purge corruption from baseball. But Judge Landis's appointment led to another controversy: Could a federal judge remain on the bench while serving as Baseball Commissioner? That controversy brought to the fore a still broader question: Where do federal judges look for guidance in resolving ethics issues?

Since 1789, every federal judge has taken the same solemn oath to "administer justice without respect to persons," to "do equal right to the poor and to the rich," and "to faithfully and impartially discharge and perform" the duties of judicial office. But for the first 130 years of the Nation's
