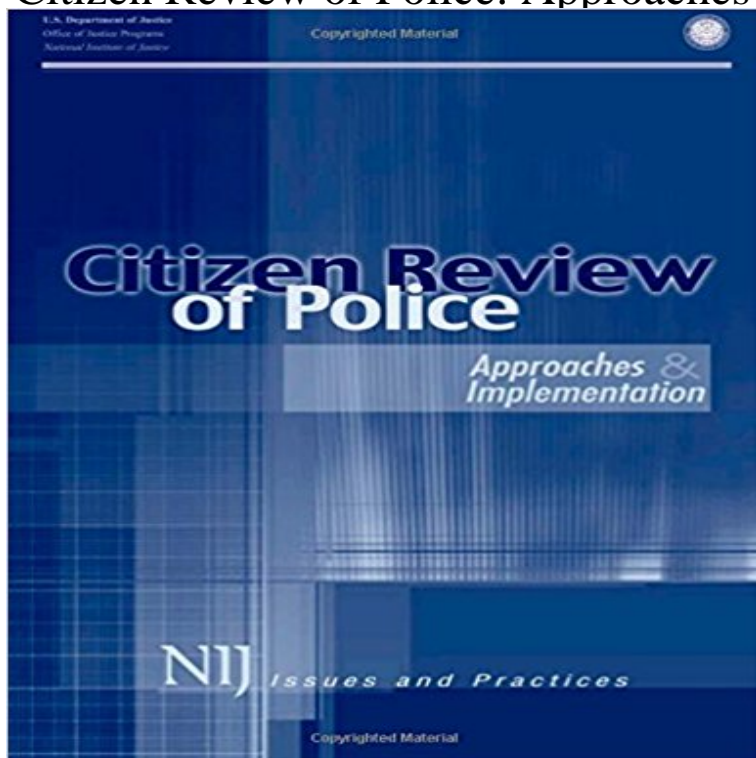


Citizen Review of Police: Approaches & Implementation



There has been a considerable increase in the number of procedures involving citizen oversight of police implemented by cities and counties in the 1990s. However, many of these procedures have had a troubled history involving serious bitter conflict among the involved parties. Citizen Review of Police: Approaches and Implementation is designed to help jurisdictions that may decide to establish wish to improve an oversight system to avoid or eliminate these battles. At the same time, the publication can help oversight planners understand and choose among the many options available for structuring a citizen review procedure. Finally, current oversight staff and volunteers may find it useful to review the publication as a way of learning more about the field.
