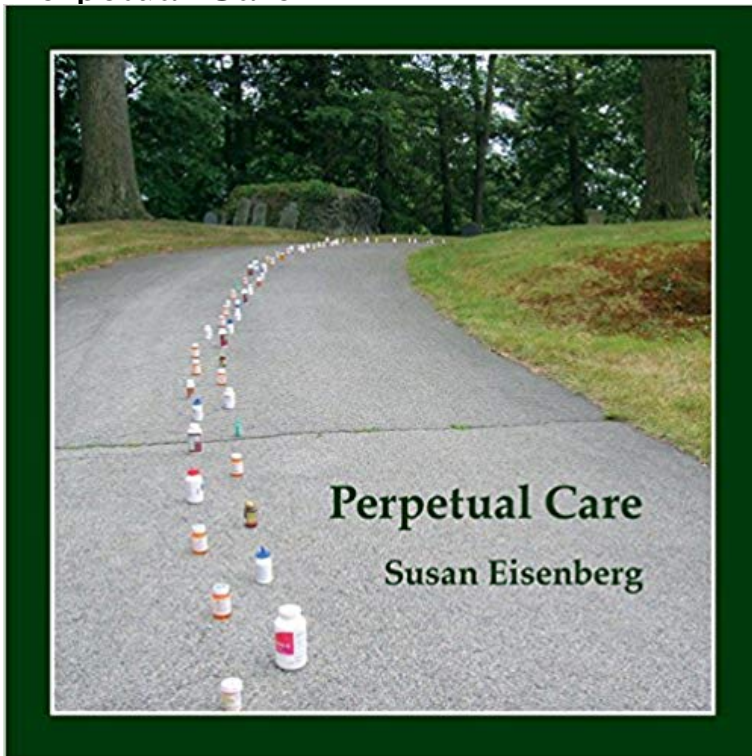


## Perpetual Care
