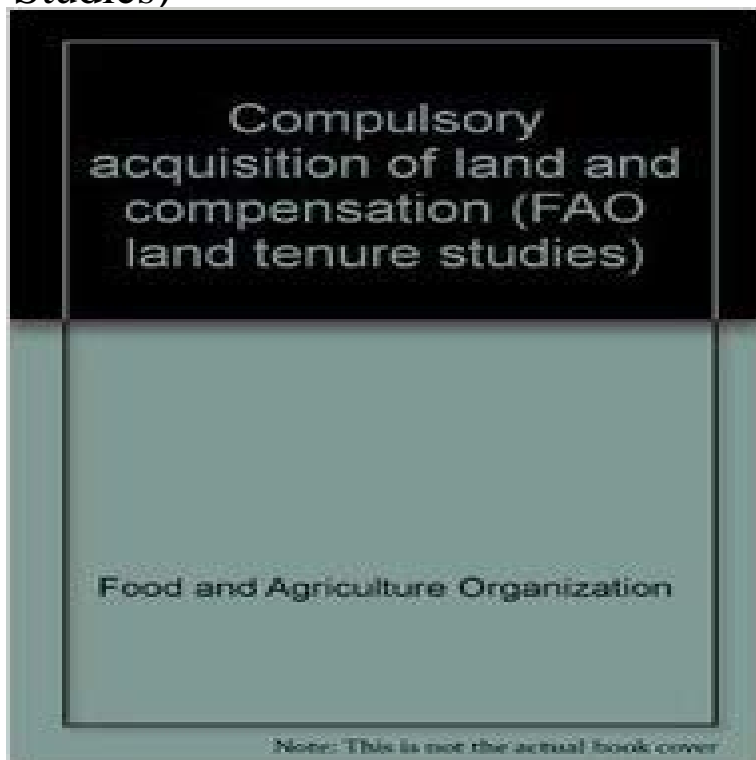


## Compulsory acquisition of land and compensation (FAO Land Tenure Studies)
