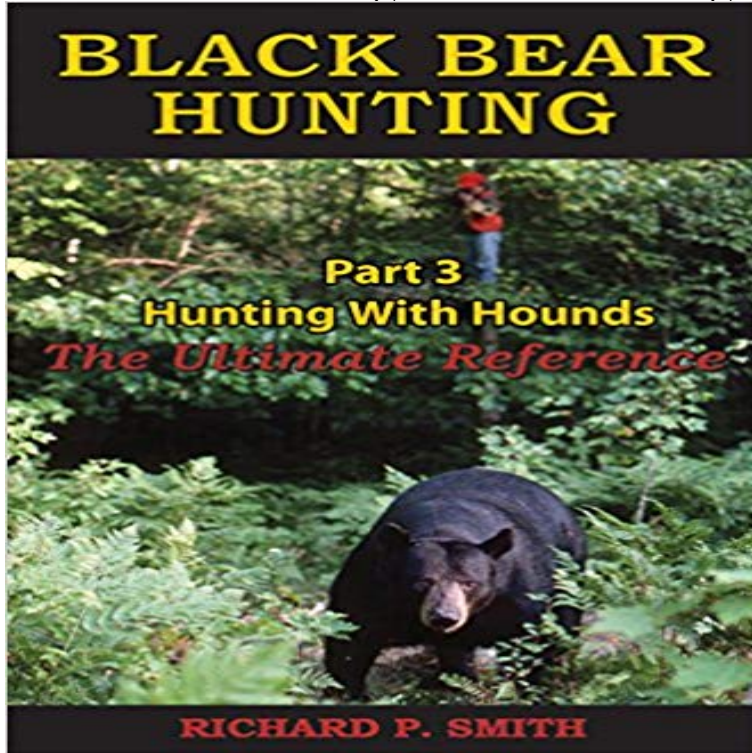


## Black Bear Hunting: Part 3 - Hunting With Hounds
