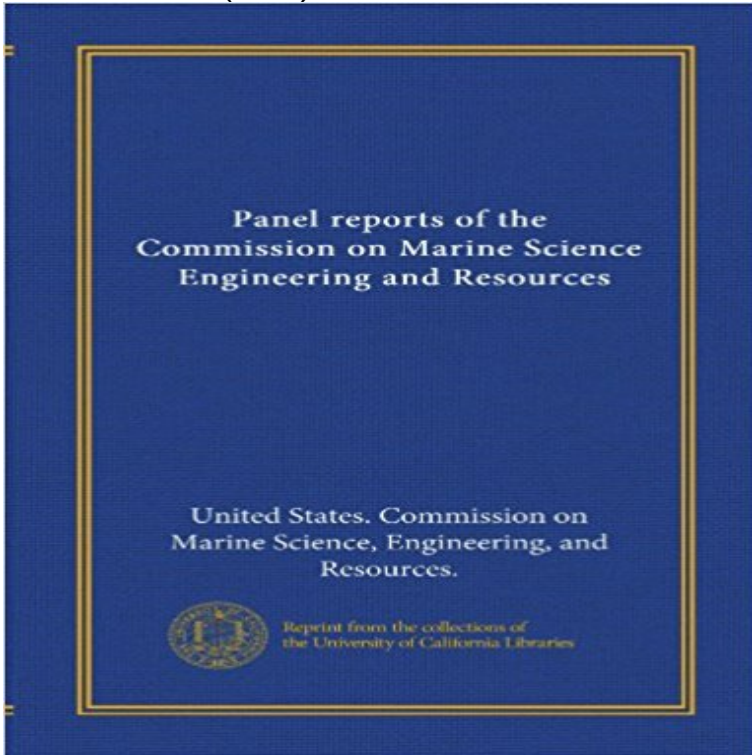


## Panel reports of the Commission on Marine Science, Engineering and Resources (v.2)
