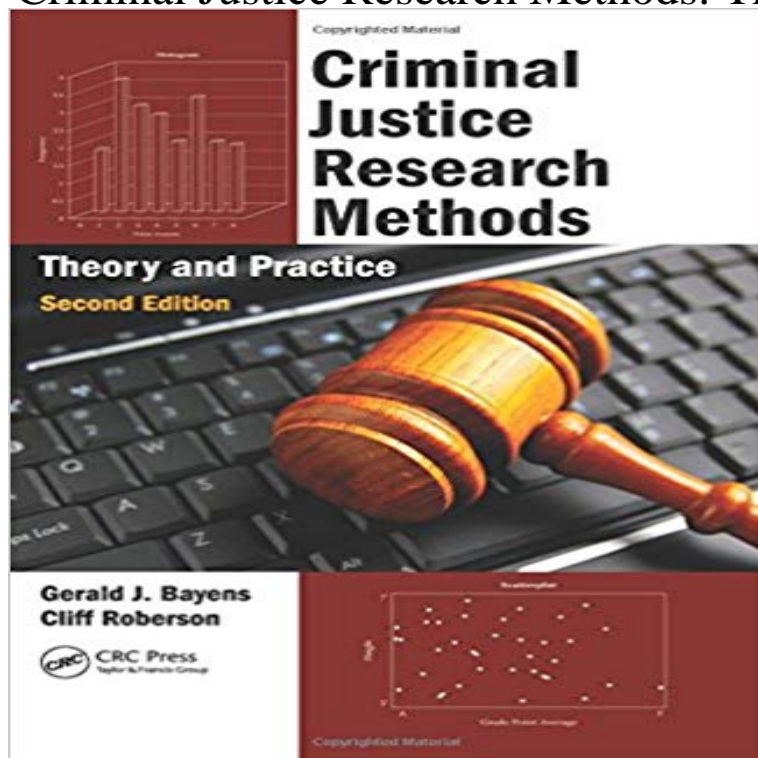


# Criminal Justice Research Methods: Theory and Practice, Second Edition
