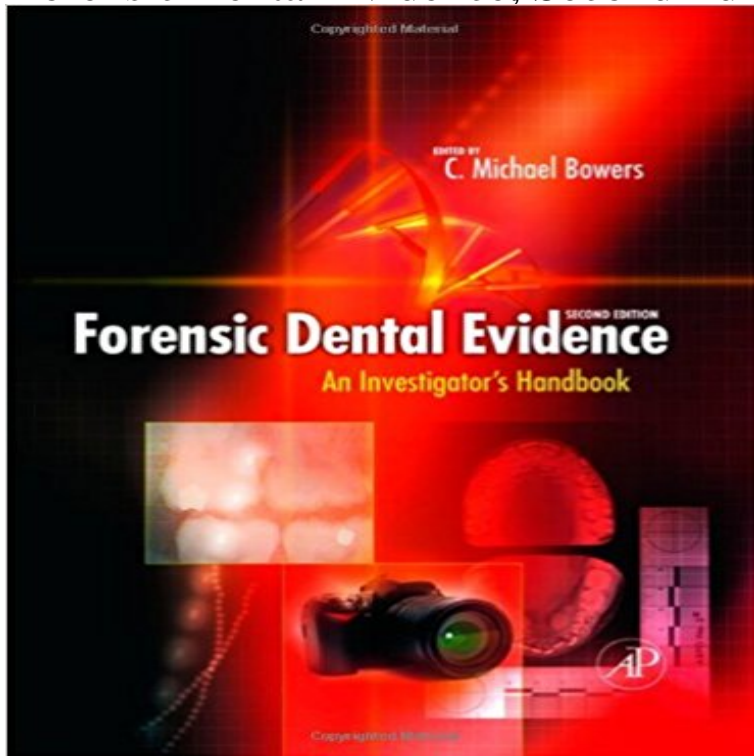


Forensic Dental Evidence, Second Edition: An Investigators Handbook
