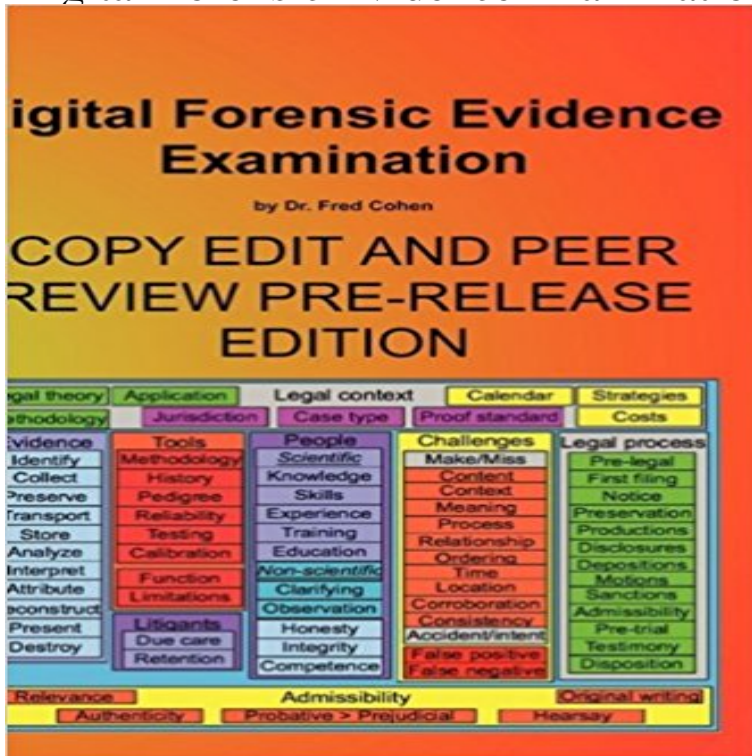


# Digital Forensic Evidence Examination
