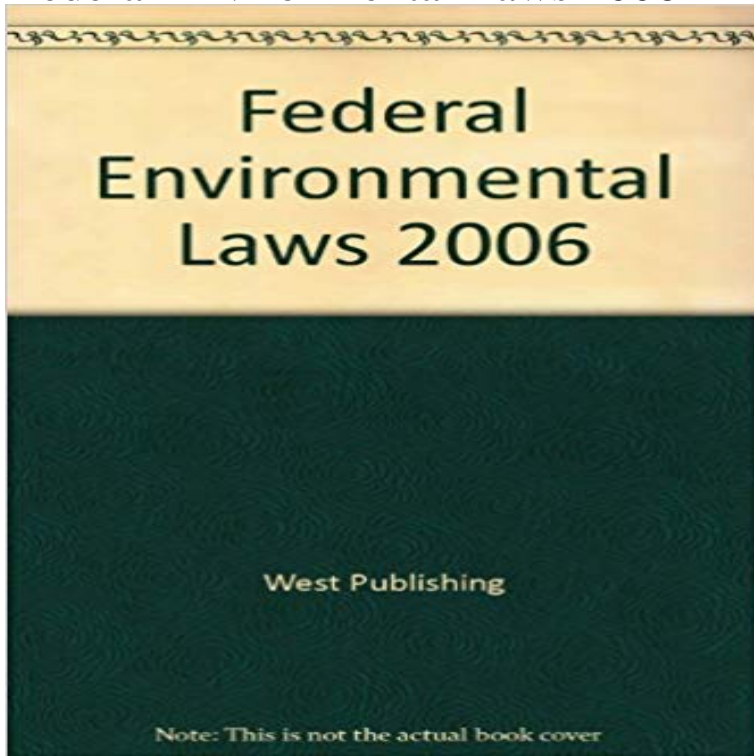


## Federal Environmental Laws 2006
