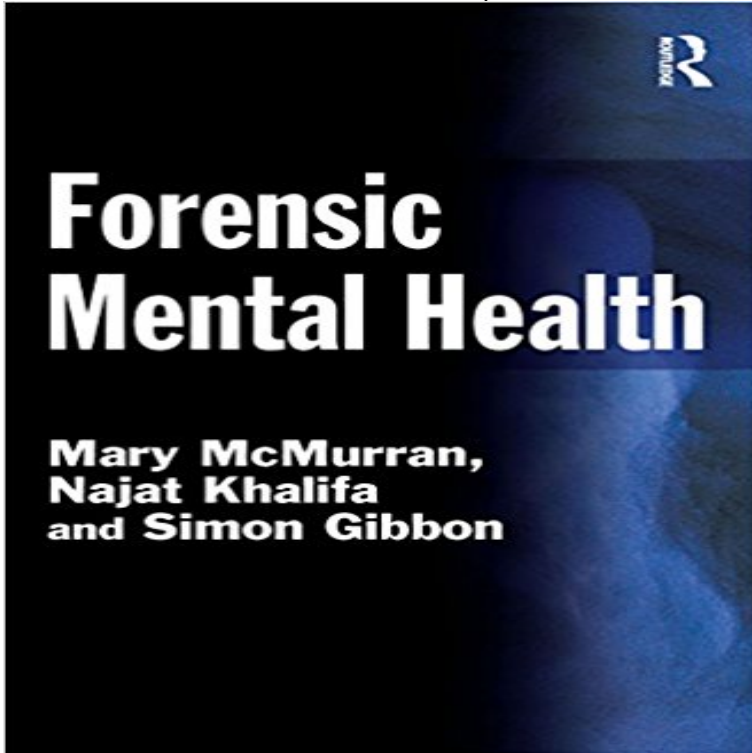


Forensic Mental Health (Criminal Justice Series)
