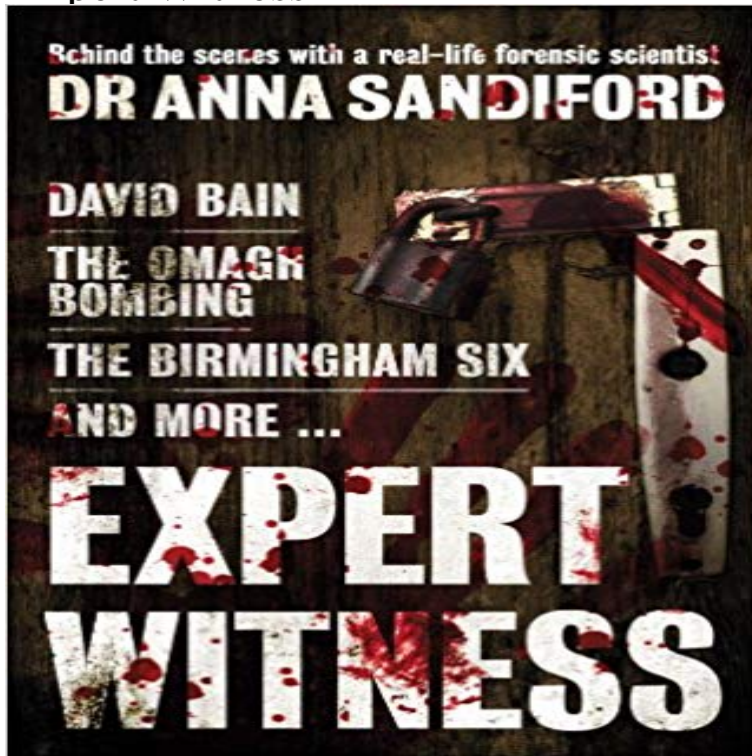


## Expert Witness
