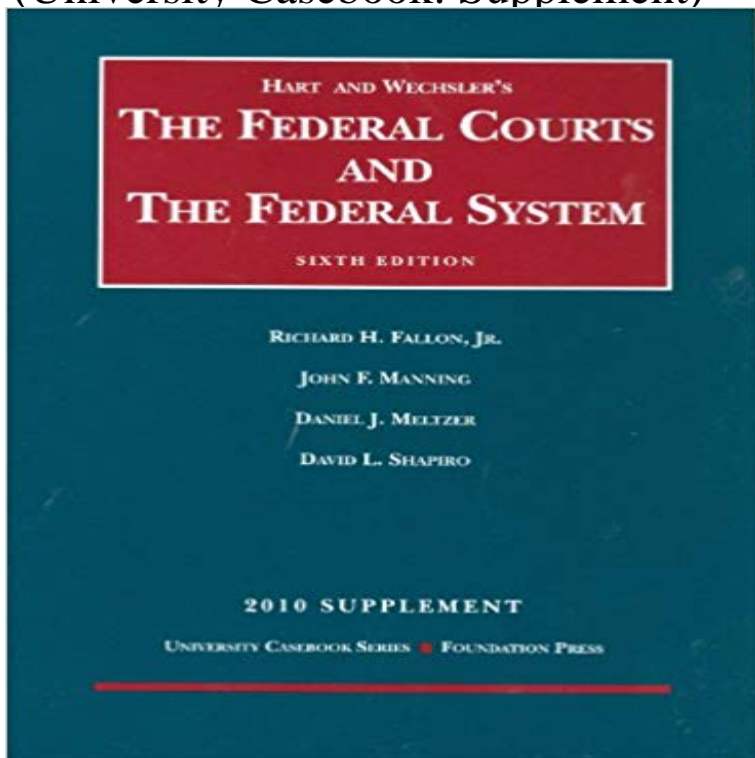


The Federal Courts and the Federal System 6th, 2010 Supplement (University Casebook: Supplement)
