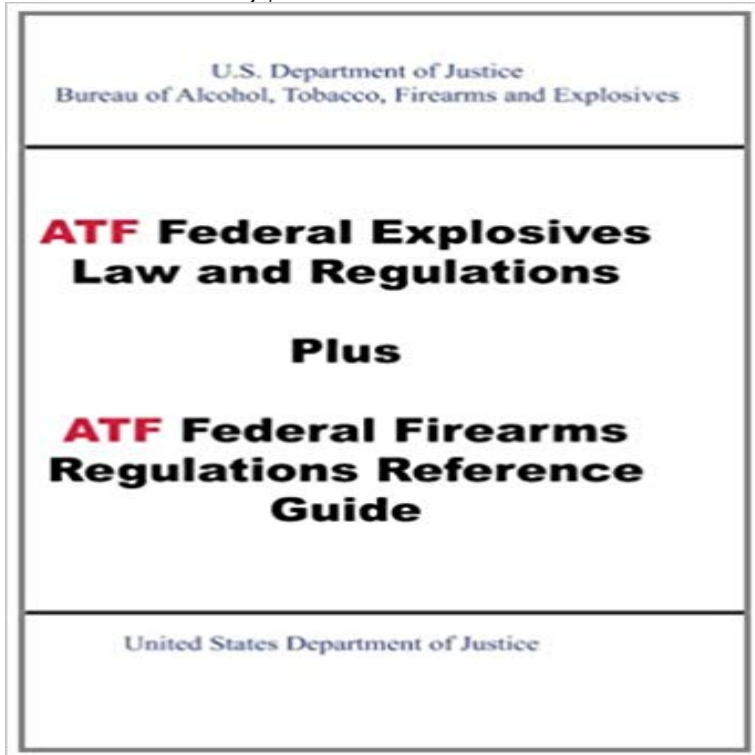


ATF Federal Explosives Law and Regulations Plus ATF Federal Firearms Regulations Reference Guide

A great value! ATF Federal Explosives Law and Regulations: the updated Federal Explosives Law and Regulations (ATF P 5400.7), generally known as the orange book. One of the goals of this publication is to help the industry ensure the safety and security of explosive materials involved in commerce. The updates include enhancements to the Organized Crime Control Act of 1970 stemming from the enactment of the Safe Explosives Act. Three of the major changes are requirements that all persons who receive regulated explosive materials in intrastate commerce have a Federal explosives license or permit, and that ATF conduct background checks on all employees possessing explosives in the course of their employment with a licensee or permittee, and an expansion of categories of persons prohibited from possessing explosives. In addition, the publication provides updated questions and answers, and addresses new rulings that give the industry flexibility through alternate methods or procedures for specific explosives regulations. PLUS: Federal Firearms Regulations Reference Guide provides information designed to help you comply with all of the laws and regulations governing the manufacture, importation, and distribution of firearms and ammunition. Accordingly, it contains the relevant Federal firearms laws and regulations. It also contains rulings, general information, and questions and answers to give you further guidance on the Federal firearms laws. The laws and regulations are in a different order from previous versions so that this publication will be easier to use. This new edition also contains additional points of contact to help you get in touch with ATF more easily.
