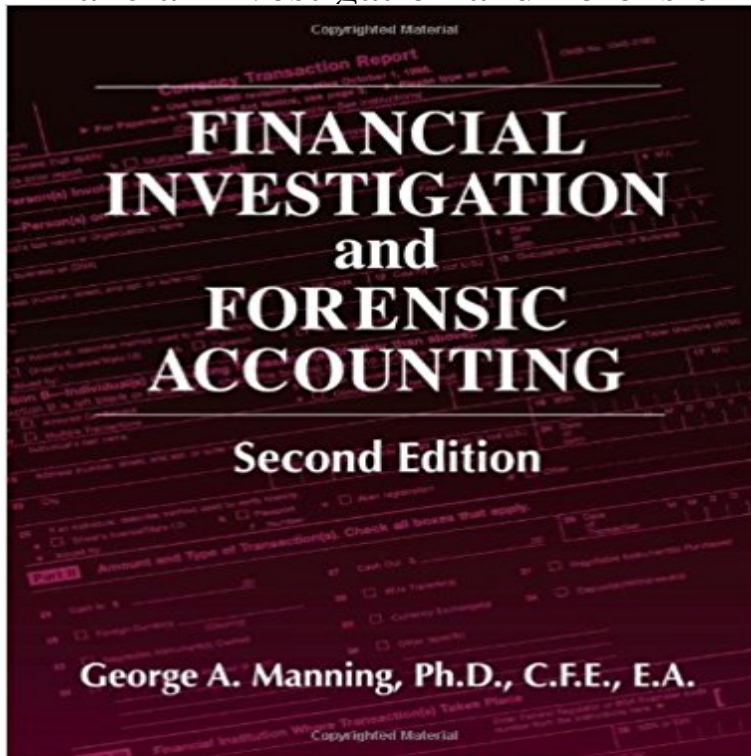


# Financial Investigation and Forensic Accounting, Second Edition
