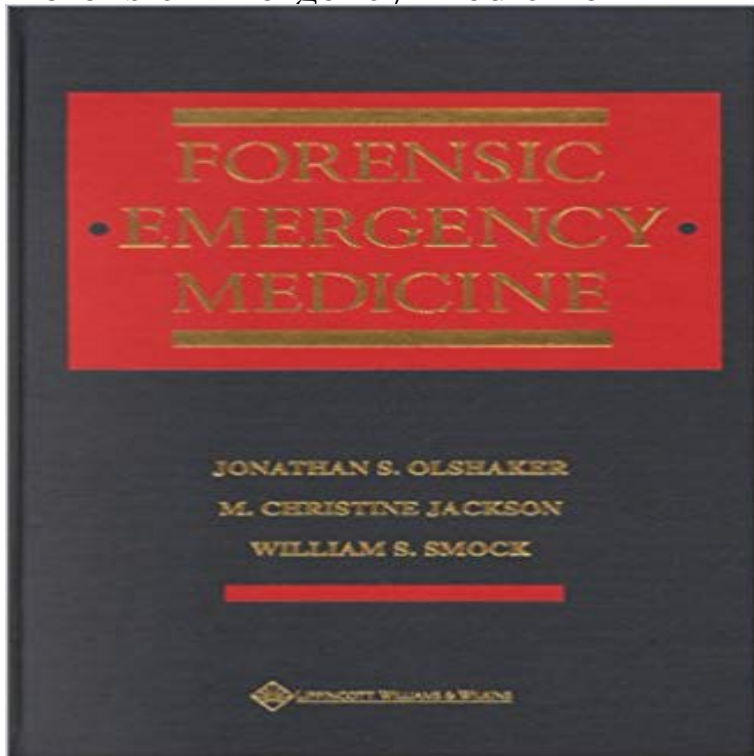


Forensic Emergency Medicine
