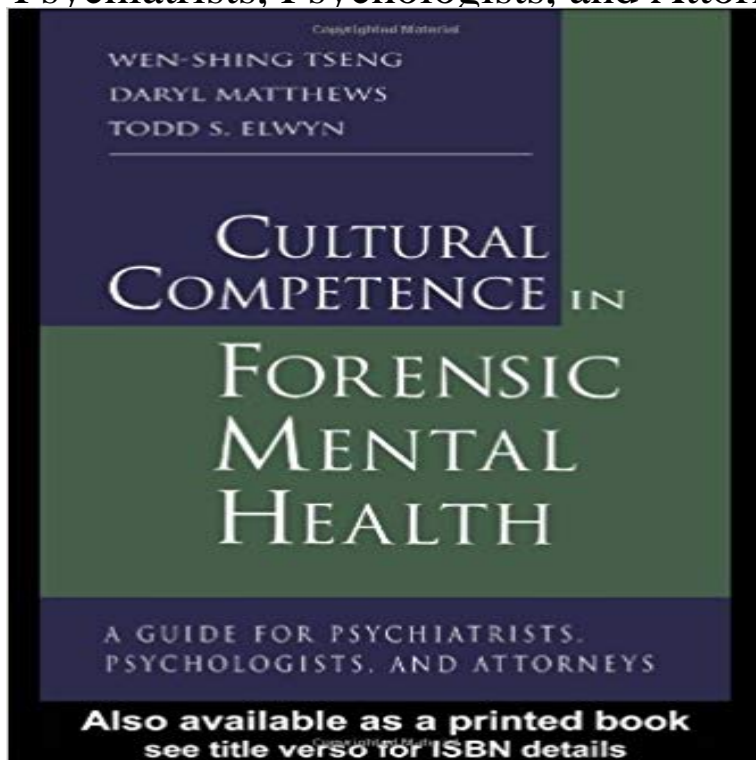


# Cultural Competence in Forensic Mental Health: A Guide for Psychiatrists, Psychologists, and Attorneys
