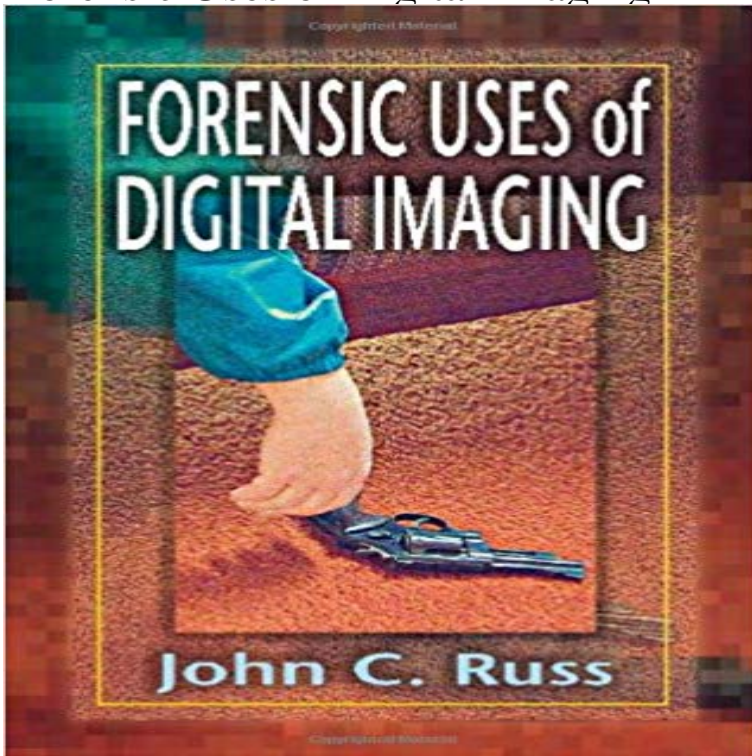


## Forensic Uses of Digital Imaging
