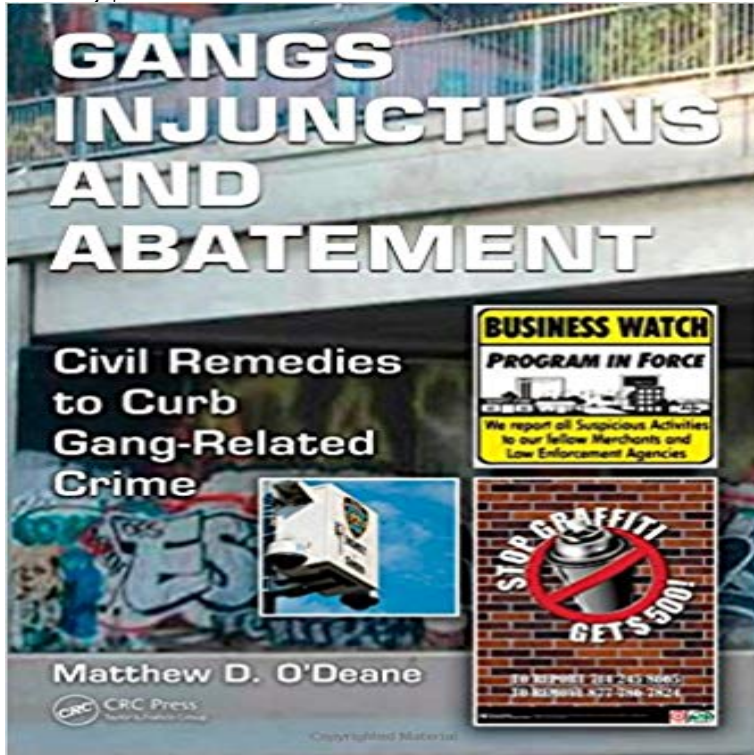


# Gang Injunctions and Abatement: Using Civil Remedies to Curb Gang-Related Crimes
