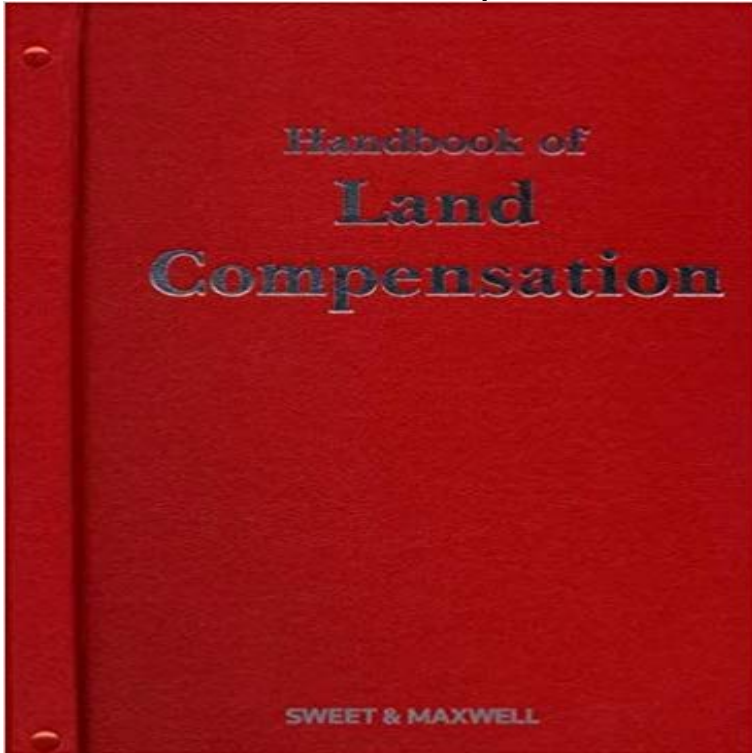


## Handbook of Land Compensation: Law and Valuation
