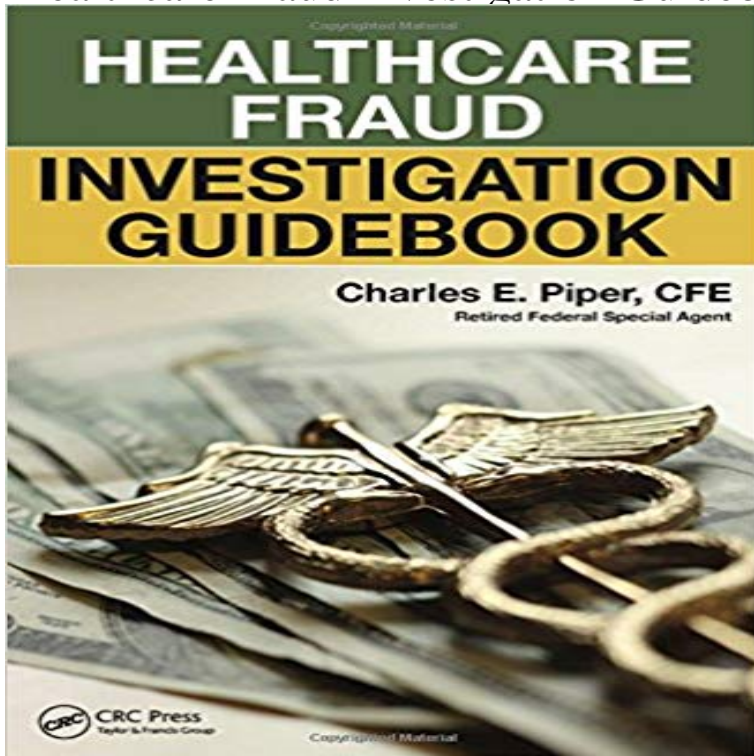


Healthcare Fraud Investigation Guidebook
