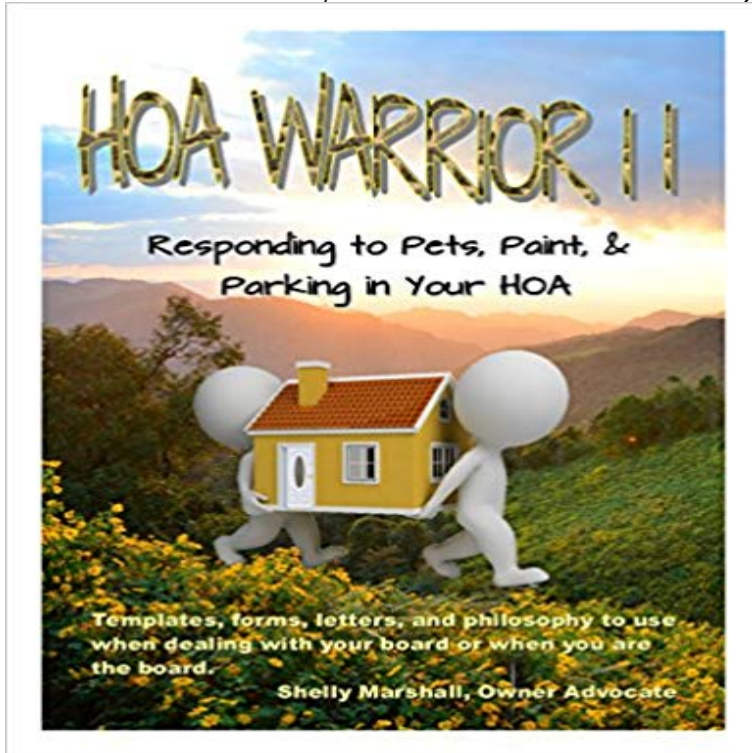

You have to worry about the management company giving kickbacks to the board or hiring their cousin Louie to do maintenance, whether the board, management or collection agency is wasting your money or even embezzling it!

You have to worry about tiny infractions of the CC&Rs that may lead to you losing your home. And you have to worry that even though there are laws in place to protect you, there is absolutely no way to enforce those laws except to sue in court. The attorney general of your state and your local law enforcement will most likely call it a civil matter, yet HOA disputes are anything but civil. There are precious few agencies that can help you, and so you must learn to protect yourself. The first line of defense is responding to your board in ways that give you the advantage. This means being professional, understanding your rights, not pissing off the trustees, and unfortunately playing the game. HOA Warrior II lays the foundation to play the game to your advantage. This is done in forms, sample letters, requests and strategic planning in order to avoid disaster.
