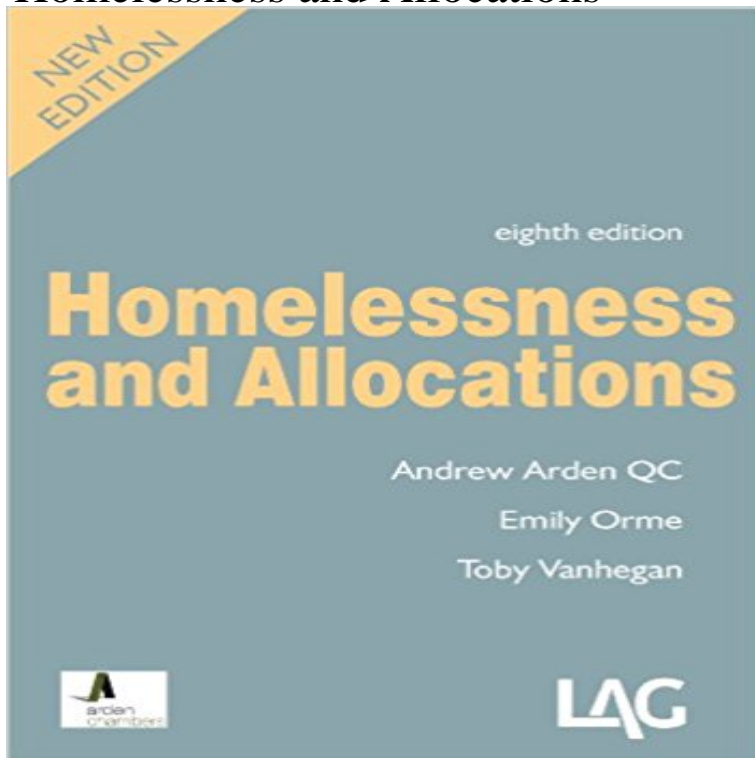


Homelessness and Allocations
