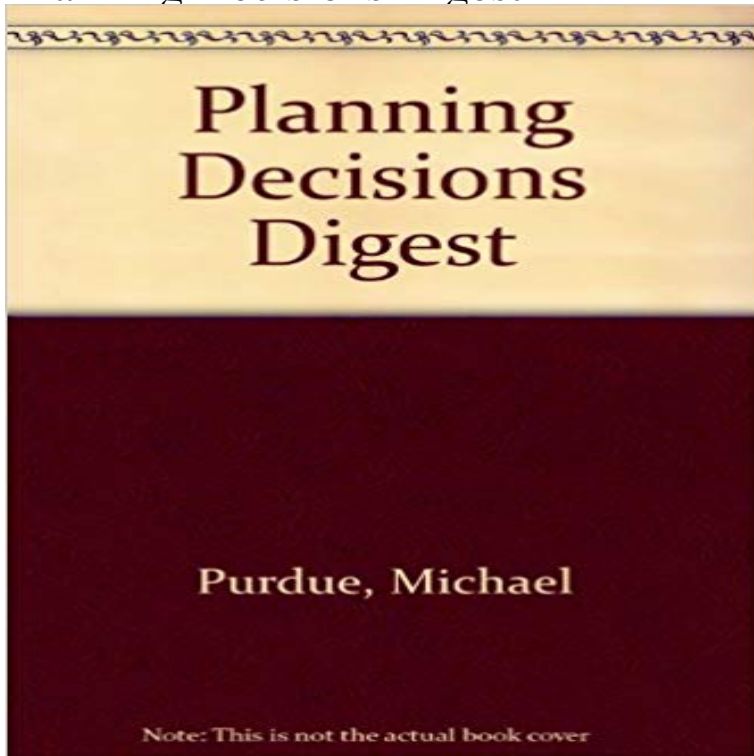


# Planning Decisions Digest
