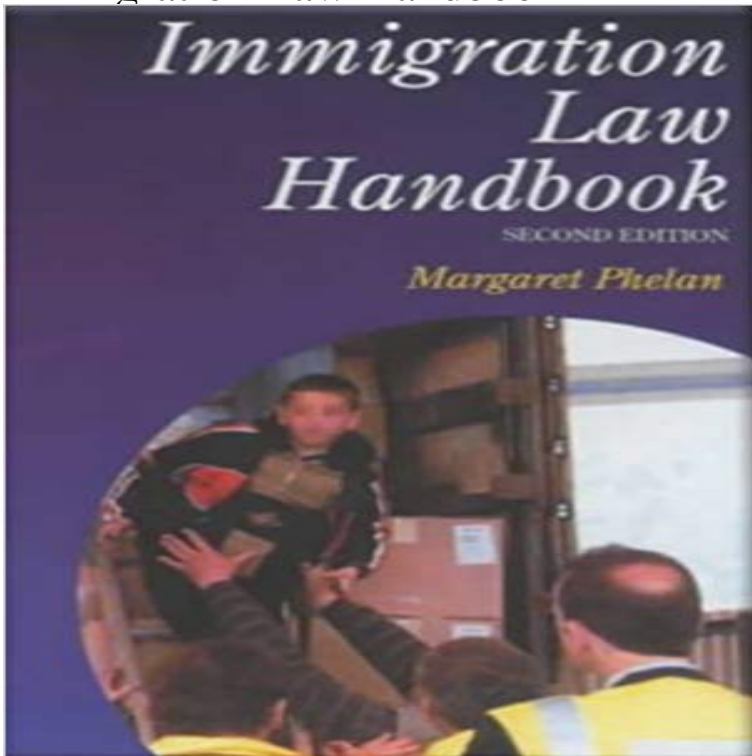


# Immigration Law Handbook
