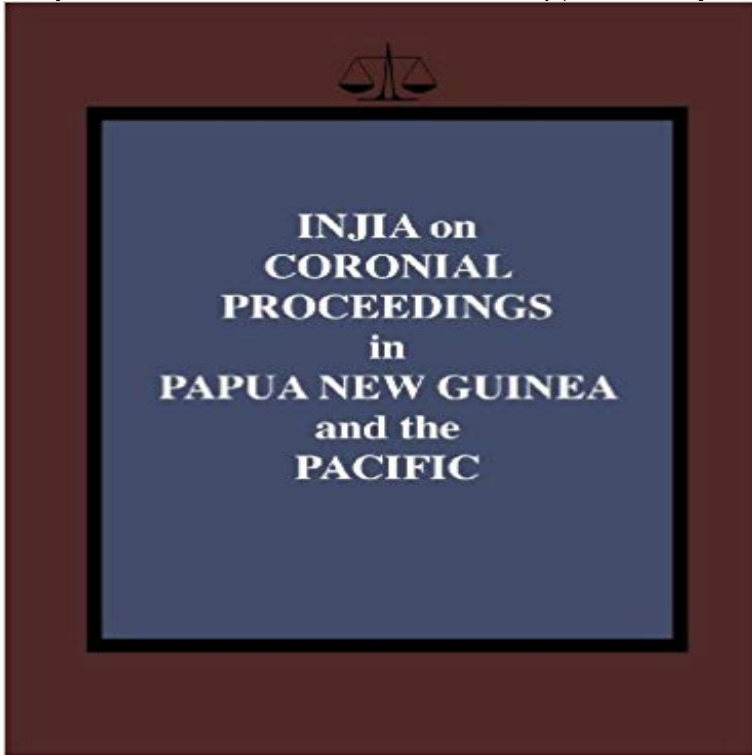


Injia on Coronial Proceedings in Papua New Guinea and the Pacific
