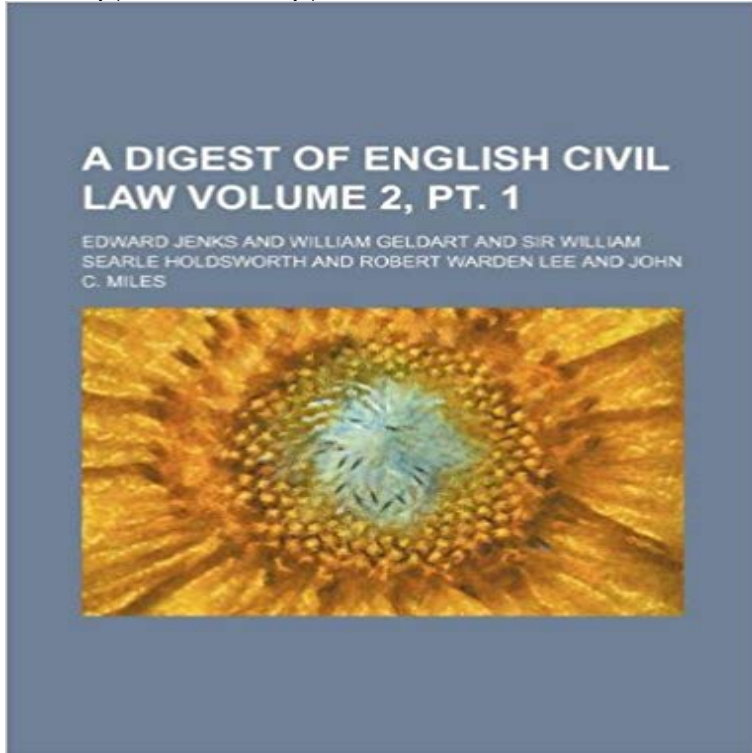

When either of two alternatives is to be performed at the promisor's option, and one of them becomes impossible after the conclusion of the contract, but before the option has been exercised, it is a question of construction in each case whether, according to the true intention of the parties, the promisor must perform the alternative which remains possible, or is altogether discharged.
