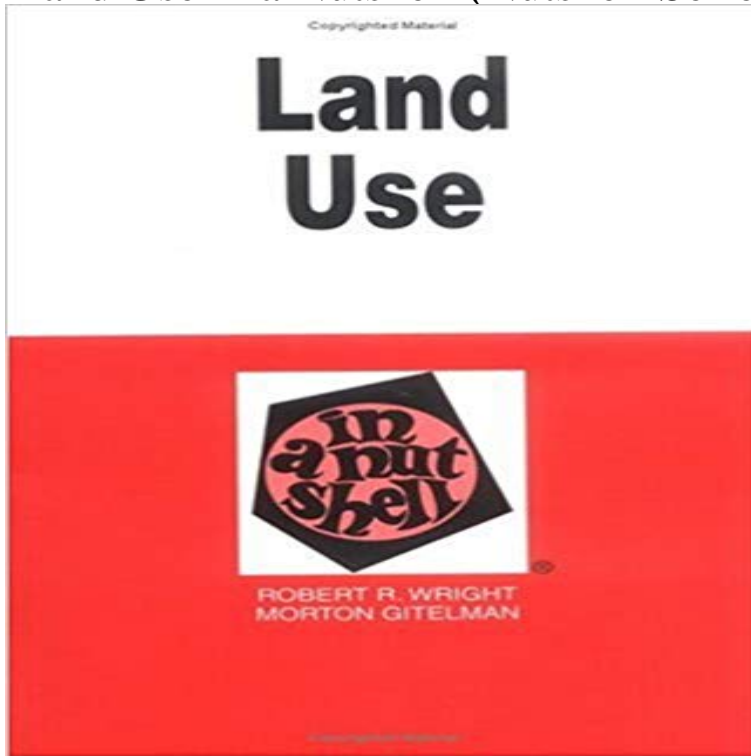


Land Use in a Nutshell (Nutshell Series)
