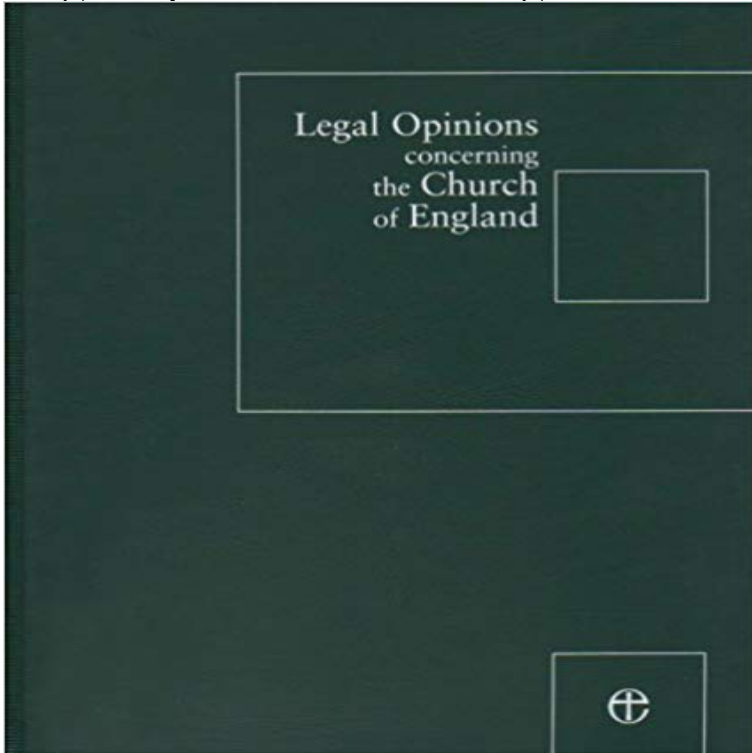


## Legal Opinions Concerning the Church of England
