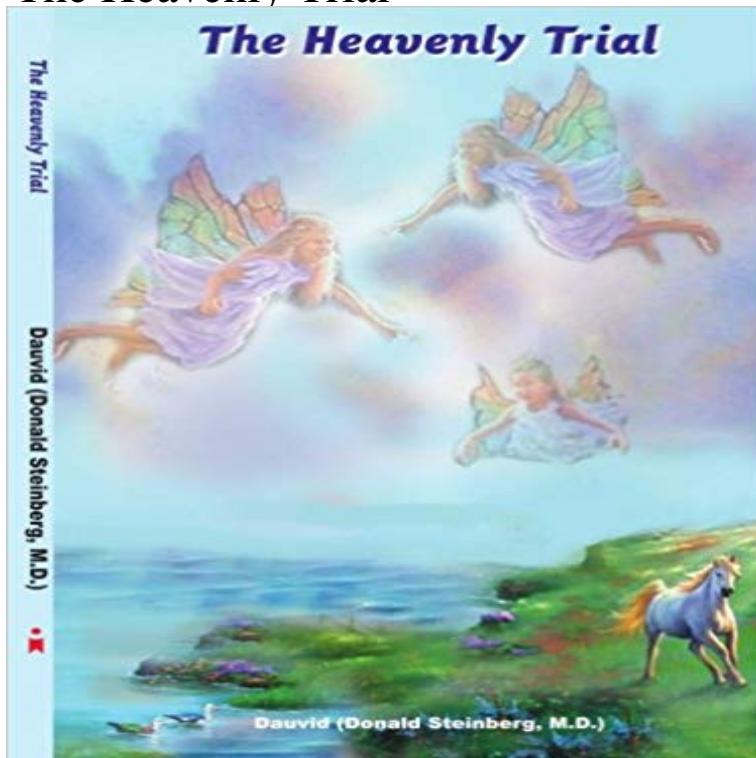


The Heavenly Trial
