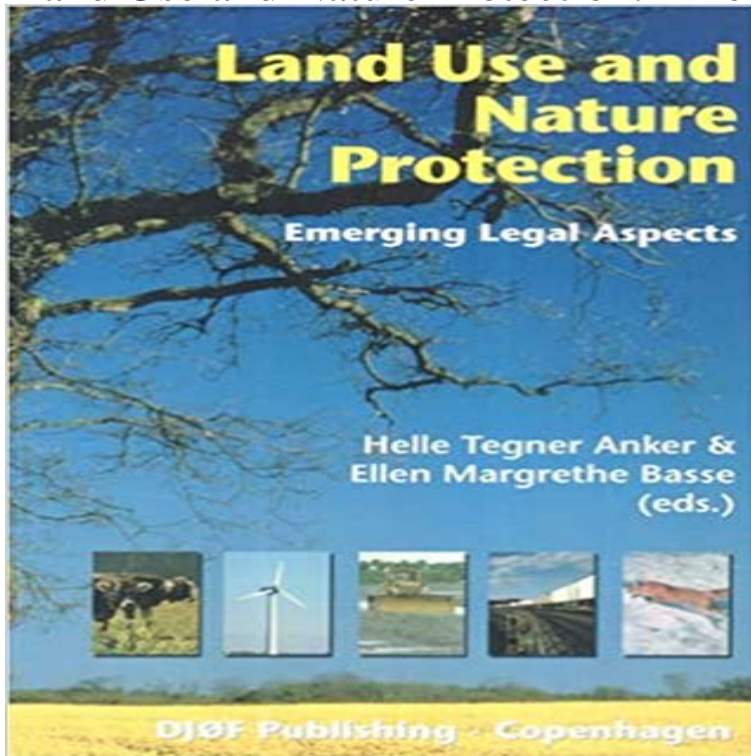


## Land Use and Nature Protection: Emerging Legal Aspects
