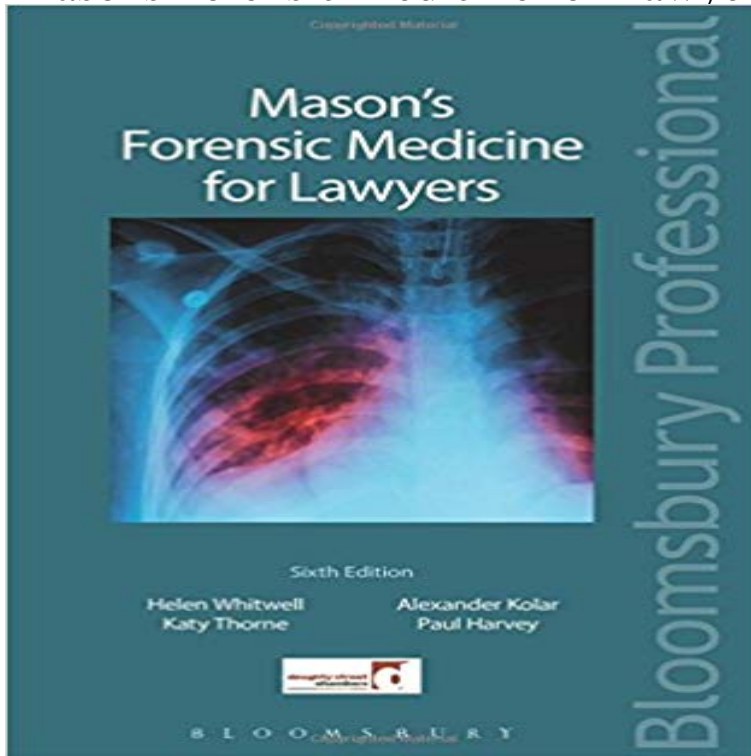


## Masons Forensic Medicine for Lawyers: Sixth Edition

Completely revised, the book is written from the viewpoint of the UK legal practitioner and medical expert witness. To this end, it provides practical guidance, including diagrams on new developments and problem areas in forensic medicine. It also offers suggestions for further reading, which will enable the practitioner to understand expert reports, as well as identify potential areas where further expertise is necessary.
