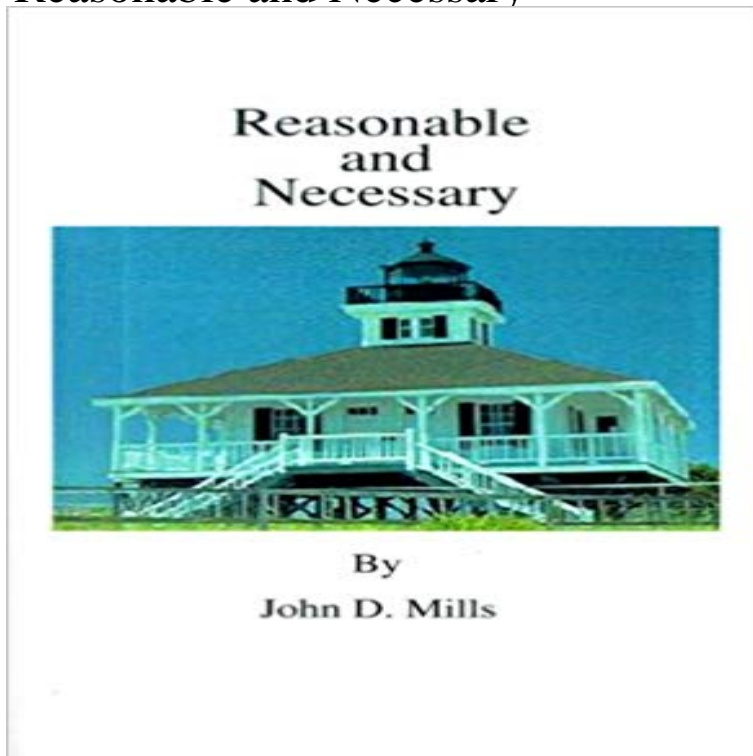


## Reasonable and Necessary
