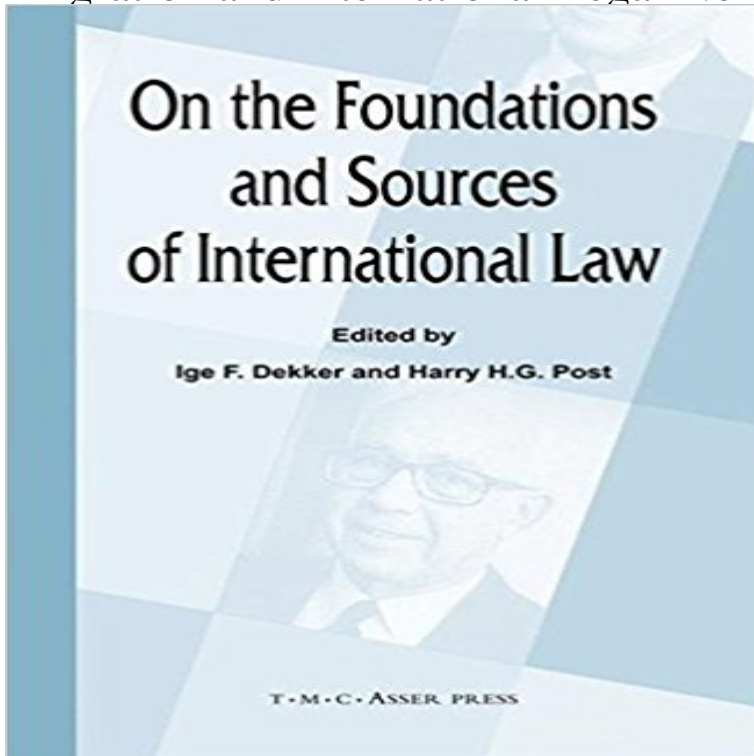


## Migration and International Legal Norms

Migration and International Legal Norms shows that, despite the absence of a comprehensive legal instrument governing international migration, there is a wide range of legal norms relevant to migration embodied in multilateral treaties and conventions, regional agreements, and customary international law. It also identifies some significant gaps in international law, recommending areas for further cooperative efforts. This volume will be of interest to scholars and policy-makers, and to all those interested in how the community of nations is responding to the increasingly significant phenomenon of international migration.
