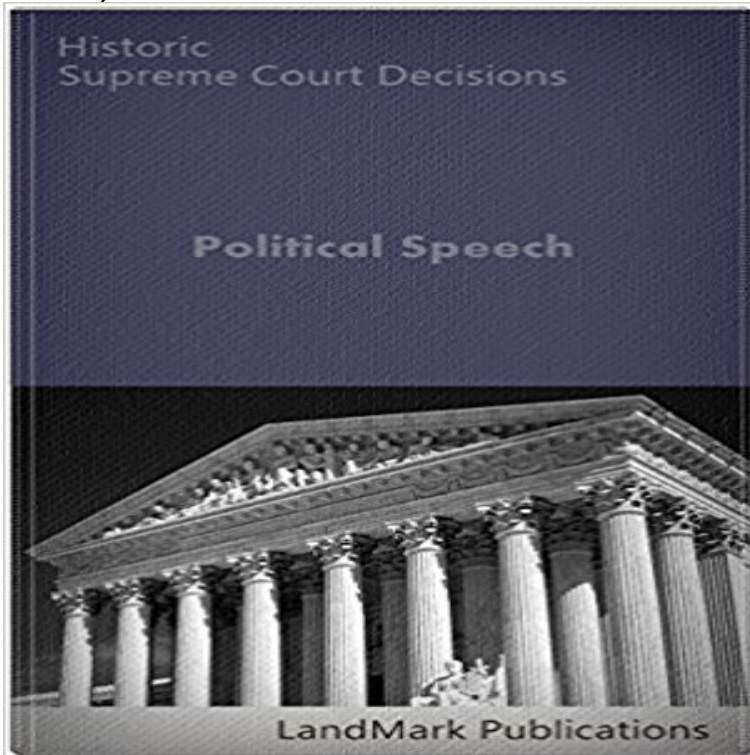


Political Speech: Historic US Supreme Court Rulings (LandMark Case Law)



This book contains the landmark decisions of the Supreme Court dealing with political speech. Included is a copy of the US Constitution, Bill of Rights and the Constitutional Amendments. A 1919 California statute banning red flags was found to be unconstitutional. *Stromberg* is one of the first cases to protect symbolic speech from infringement by a state. The *Broadrick* case upholds an Oklahoma statute which prohibits state employees from engaging in partisan political activities. *Citizens United* was decided in 2010 and holds that corporate funding of independent political broadcasts for candidates in an election cannot be limited because of the First Amendment.
