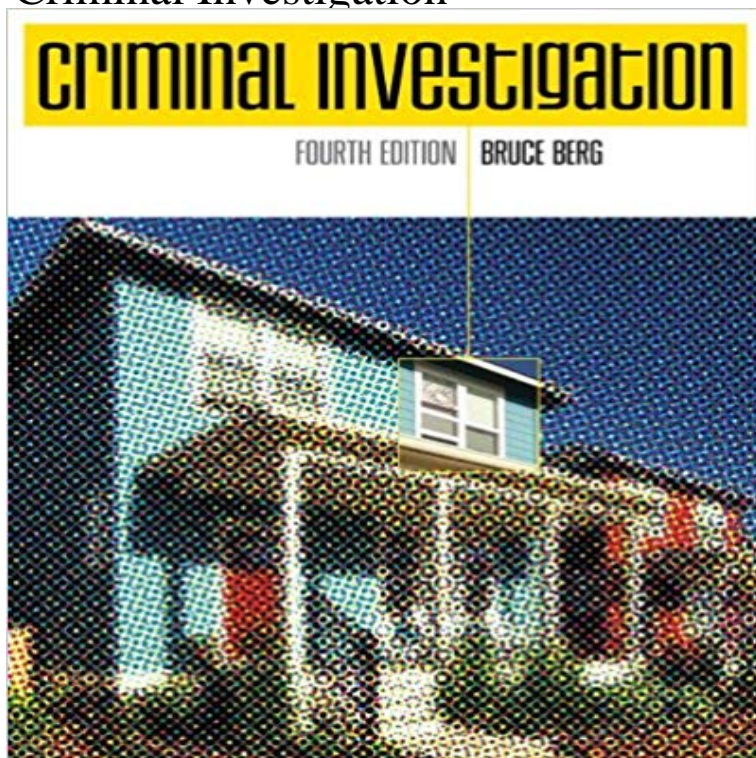


## Criminal Investigation
