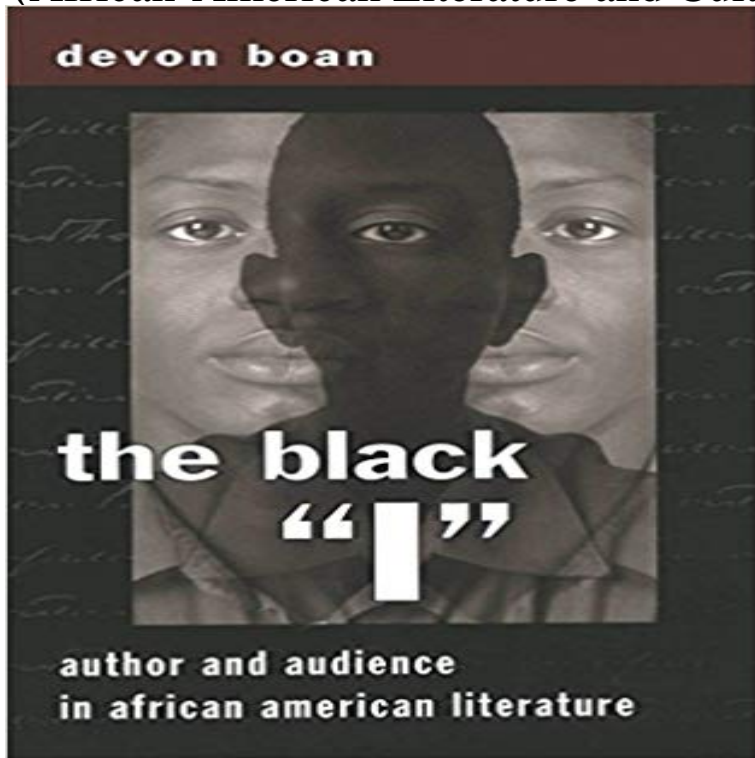


The Black I: Author and Audience in African-American Literature (African-American Literature and Culture, Vol. 2)
